



Friends of Duchess Wood (FODW) – Activity Plan 2025-2027

Updated October 2025

This document sets out list of tasks which FODW proposes to carry out over the period 2025 to the end of 2027 and with the agreement of and Luss Estates Company (LEC) as owners of Duchess Wood. Some of these tasks are already taking place while others are new.

Some of the proposed work will require external funding. This will come from grant application, FODW funds and, where possible, a contributions in the form of professional expertise, labour or materials. Some activities will require specialist advice. We would propose to consult. LEC and where appropriate seek additional advice where required from other sources.

Note In October 2024 LEC put the majority of the Wood up for sale but intend to retain ownership of some parts of the Wood. As at August 2025 while a commercial agreement for the sale with a third party has been agreed sale process is currently in the hands of both parties Solicitors.

For completeness a number of tasks currently being progressed such as the sapling planting, the feasibility of upgrading burn crossings and safety surveys are included in the list.

The planned actions are grouped under a series of headings:

- Friends of Duchess Wood structure and organisation
- Woodland Management
- Public Access
- Maintenance Amenity
- Education and Citizen Science
- Recreation and Events.

The proposed actions and timelines are set out in the table below. At this stage no financial cost has been allocated to the activities proposed. This will be done on an activity-by-activity basis.

Sycamore	Cut down sycamore regeneration on stumps and where saplings naturally regenerate.	On going.
100 oak plantation	Continue to monitor growth and thin again to half the current population in 3 to 5 years. Long term objective is to create 2 to 4 specimen trees in this area to grow to maturity which will take 25 to 50 years. Trees planted in 2010	Keep understory cut down to maintain access

Footpaths	Following the creation of two new footpaths in 2022/23 no new paths are currently planned. A nature corridor linking Castle Wood, through Duchess Wood, to Glenoran and on to Ardenconnel, passing through Aldonaig Glen ancient woodland and proceeding above Shandon via Blairvadach and ending in the ancient woodland at the MOD base.
